4. Attend the workshop – have the instructor sign the attendance form.
5. Attach the receipts to the attendance form and give/send it to CDR.
6. Meet with a CDR Staff member
7. CDR will send you a check within 1 week to reimburse you.

By submitting an application, you agree to meet with a CDR staff member twice – once prior to the workshop, and once after.
